1. What are cookies?

Cookies are small text files that are stored on the user's device when visiting a website. They are used to enhance the browsing experience, store users' preferences, and provide information to the website owner.

2. Types of cookies

In order to ensure greater transparency and control over your online privacy, below is an overview of the different types of cookies used online. These descriptions provide a list of common types of cookies you could find online. The specific types of cookies used by a particular website may vary depending on its functionality and purposes.

- **Essentials cookies** are necessary to allow the basic functionality of the website. They enable core functions such as page navigation and access to secure areas of the site. Without these cookies, the website may not function properly.
- Functional cookies store choices made by the user (such as username, language, or region) and provide
 enhanced, more personalized features. For example, they may remember preferences such as font size, page
 layout, or colors.
- **Advertising cookies** are used to display ads that are more relevant to the user's interests. They are also used to limit the number of times an ad is displayed and to measure the effectiveness of advertising campaigns. They are usually placed by advertising networks with the website operator's permission.
- Analytical or performance cookies, collect information about how users use the website. For example which
 pages are visited most often and whether users receive error messages from certain pages. These cookies do
 not collect information that identifies a visitor. All information collected is clustered and therefore anonymous.
 They are used only to monitor the function of the website.

- Session cookies are temporary text files that are deleted once the browser is closed. They are used to track user
 activity during a browsing session and are essential for the operation of certain website features.
- Persistent cookies remain on the device for a specified period, even after the browser is closed. They are
 activated each time the website that created the cookie, is visited. Persistent cookies are used to remember
 user preferences and actions across multiple sessions.
